- Valid Registration with Pakistan Engineering Council in the relevant category or above discipline keeping in view the bid costs for items shown above.
- For Electrical work valid license from inspectorate of Electrical License in Mirpurkhas region with respect to works, shown above.
- Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion.
- List of work in progress along with copy of letter of Award.
- List of Machinery and equipment available with status of its ownership.
- Registration with license Tax Department (NTN copy) and Sindh Revenue Board (Sales Tax Registration) and copy of CNIC.
- Undertaking on stamp paper that firm is not involved in any litigations, Department rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- The 2% Earnest Money shall be submitted in favor of Director Finance, QUEST Nawabshah in shape of Call Deposit issued from scheduled bank, accompanied with bidding documents.
- Cheques shall not be entertained for this purpose.
- Certificate of bank showing credit worthiness along-with current bank statement.
- Affidavit to the effect that firm has not been black listed.
- Affidavit to the effect that all documents, particulars and information furnished is true and correct.
- In case the applicant not fulfills SPPRA Rules-2010 (Amended 2013) or aforesaid conditions, the applications for issuance of bidding document will not be entertained.
